

How Wozityou uses your personal information

We treat your confidentiality very seriously. We want you to feel comfortable using our service so please read the following to learn more about how our Privacy Policy which also gives you information about cookies and how we use them.

This document describes information collected by Wozityou, how that information may be used, with whom it may be shared and your choices about such uses and disclosure.

Consider the policy document carefully because by using our service you will be deemed to accept and agree to our policies.

Wozityou is a trade mark of MediaBase Direct Ltd which is a company registered in England (Company No. [2651463](#)) whose registered office is at TML House, The Anchorage, Gosport, Hampshire, PO12 1LY . This means this policy and any dispute arising out of it shall be governed and construed in accordance with English Law.

The information you provide

When you subscribe to our service you will supply us with your name, nickname, email address, password, mobile telephone number, your date of birth and a photographs and Videos.

The information automatically collected

When you access our services, our servers automatically record information on our server such as logs from your browser or mobile platform, including your location because collecting this information is an integral part of the service. By using our service you consent to receiving unsolicited messages from other Wozityou users in your locality.

How is the information shared?

MediaBase Direct Limited does not rent, sell or share the personal information which is uniquely yours e.g. your date of birth (other than to other users as part of our service).

We do not share your personal information with third parties (i.e. outside the MediaBase Direct Group) other than as required by law e.g. Enforce our Terms of Use Agreement including investigation of potential violations of that agreement or to investigate and defend ourselves against any third party claims or allegations or to detect prevent or otherwise address fraud, security or technical issues.

All personal data will remain at all times your personal property. Should you decide to stop using our service for any reason we will not retain your personal data in a way which is directly referable to you i.e. it will remain anonymous.

Our service allows you to share information about yourself with other individuals and you should consider your own privacy and personal safety when sharing your information with anyone. Also when sharing information about others please consider their safety and privacy and get their consent for that sharing.

We may however share information with others in an aggregated form that does not directly identify you. You can opt out of receiving promotional messages from us such as emails, text messages by visiting the settings page of your account.

MediaBase Direct Limited does not provide any of your uniquely personal information to any of the third parties who we may select to offer you vouchers, discounts, offers or other promotional material.

By interacting with or accepting any such offer you are consenting to the possibility that the promoter will make an assumption that you meet the targeting criteria behind the promotional material e.g. that you are older than 18 years of age from a particular geographical area.

Confidentiality and Security

We allow access to personal information about you to employees who we believe generally need to come into contact with that information to provide products or services to you or in order to do their jobs.

We have physical, electronic and procedural safe guards that comply with our legal obligations to protect personal information about you.

In particular your account is protected by a password for your privacy and security. You will need to protect unauthorised access to your account and personal information by selecting and protecting your password appropriately. It is also a good idea to limit access to your computer/mobile and browser by signing off after you have finished accessing your account.

What personal information can I access?

Wozityou relies on information about you from your Facebook account and also enables you to access the following information about you for the purposes of viewing and in certain situations, updating that information ensuring that it is accurate and complete. You can access this information on the Wozityou site by visiting the user settings page you will be able to update your personal information including:

- Email address
- Photographs
- Videos
- Contact name
- Personal Bio
- Gender
- Age (visual reference)

What happens to my personal information if I close my account?

After your account has been closed (please note it may take us 28 days to achieve this task) we will remove all user sourced information e.g. pictures and messages, but we will retain anonymised information such as may be required for our operational activities. Your cookies will not be retained by us.

Children

The safety and privacy of children is extremely important to us. That is why your information will only be shared with users of the same age group. See our [Terms of Service](#) for more detail.

Our registration process seeks to prevent children from under the age of 13 from becoming members. If it comes to our attention that a child under the age of 13 is a member then that member will be asked to provide such evidence as we may reasonably require that they are at least 13 years of age, failing which we will immediately terminate the user's account.

Our service is UK based and the Children's Online Privacy Protection Act 1998 (COPPA) does not apply to us (it is a U.S. Federal Law). Notwithstanding this and the fact that COPPA only applies to children under the age of 13, we have adopted the following additional measures of protection:-

- Notice – parents are provided with notice of all children under the age of 16 who have applied to become members.
- We only collect such personal information as is necessary to become an active member of the site.
- We provide a facility to terminate a user's account that may have used a false age or parental email address to become registered.
- It is an inherent part of the way the site works that personal information/spots do not remain accessible to other users for more than 48 hours.

Will there be changes to this Privacy Policy?

This document may be changed from time to time to keep up with any changes in our service or the law.

Users are bound by any changes to the Privacy Policy when they use the service after such changes have been made but we will notify you by email if we make any major changes to our Privacy Policy.

Cookies

Wozityou uses cookies, IP address, clickstream and URL information to improve the content of the Wozityou website, the quality of Wozityou servers, and to provide enhanced features to users.

We use cookies to save UserIds, session validators, and on users' browsers and hard drives, and may use them to provide tailored products or services to those users, as they become available. We also cross-match user information with information collected from cookies and clickstream data in order to test features of the Wozityou website and to better personalise our various offerings for users. IP addresses also help us to diagnose problems with our server, to administer the Wozityou site and to otherwise provide the Wozityou service to its users.

IP addresses will only be disclosed to a third party if we believe in good faith that the law or legal process so requires, or to protect rights or property of MediaBase Direct Group or others. From time to time we may extend various discounts or offers from various partner companies, including news or additional details on products and services.

A user's usage history may result in specifically tailored special offer screens or products. We may also produce aggregate reports for our partner companies for example we may report to advertisers the number of users who clicked on a voucher offer. This information will not include personally identifiable information about a user or a specific user's online usage patterns.
