

Wozityou TERMS OF SERVICE

Please read this Terms of Service Agreement before accessing Wozityou services. This is important because this Agreement sets out the basis upon which you agree to conduct yourself as a member of Wozityou (“the Member”).

Copyright

The Member acknowledges that Wozityou is a registered trademark of MediaBase Direct Limited (“MediaBase Direct Group”) and Members should not engage in any activity which may infringe or seek to infringe MediaBase Direct Group’s proprietary rights in this regard.

Age Restrictions

By completing our registration process you confirmed that you were at least 13 years of age. Please note that if you are under 13 years of age you are not permitted to become a Member of Wozityou. By completing our registration process you warrant to us that you are 13 years of age or older and that you have the full consent of your parent/guardian to register and use our service and that you will be legally bound by the terms of this agreement.

No member may use our service where to do so would be prohibited by any law or regulation applicable to the legal jurisdiction in which you reside.

Parents

If your child is under the age of 13 and has joined using a false age, or you have reason to believe your consent was not properly obtained for any reason, please notify us at contact@wozityou.com and we will immediately cancel your child’s account and remove all their personal information displayed on the site.

Member Conduct

- Wozityou reserves the right to terminate your access to and use of our services if, in our view, your conduct falls short of any of the following guidelines:-
 - Members shall not engage in any activity which may in any be construed as harassment of a fellow user.
 - Members shall not misrepresent their identity or impersonate any person including any employee or director of MediaBase Direct Group.
 - Members shall not use any words or engage in any activity which is offensive, abusive or racist.
 - Members shall not use the Wozityou application or website to post, share promote, depict, solicit or exchange photographs which are indecent or harmful to minors.
 - Members shall not post content which displays pornographic or sexually explicit material of any kind.
 - Members shall not use the service in any way which may be connected directly or indirectly with any illegal activities. For example, but not limited to, starting a riot.
 - Members shall not attempt to gain unauthorised access to the MediaBase Direct Group database or computers
 - Members shall not engage in any activity that will lead to the destruction or otherwise interferes with the performance or quality of the Wozityou application and website.
 - Members shall not engage in any activity which is designed to solicit or otherwise obtain another Member’s password or other personal information.
 - Members shall not post any information which creates or may create a breach of privacy or give rise to a security risk to any other Member or person.

Monitoring

Wozityou will monitor the services to enforce this Agreement, but in doing so does not guarantee that any such monitoring it does perform will be to the Member’s satisfaction. Upon learning of any infringement of this Agreement by a Member, or any other conduct by any Member which is considered by Wozityou to be inappropriate then Wozityou may in its absolute discretion terminate or restrict access to and use of its services to that Member. Alternatively Wozityou may require such Member to remedy any such breach any/or take such steps as Wozityou may require as a condition for the Member remaining a Member. The decision by Wozityou in these circumstances shall be final.

Member Account and Password

To use Wozityou, you must register an account your Facebook login, this implies you are authorizing us to access certain information in your Facebook account, including information about Facebook friends you might share in common with other Wozityou users. By allowing us to access your Facebook account, you expressly acknowledge and agree that we may obtain and share your name and multiple profile pictures, as well as the name and profile picture of your Facebook friends who are common Facebook friends with other Wozityou users in your network or geographically nearby.
